## John Vogel (Trinity, Wauwatosa)

Vogel is an active member at Trinity, Wauwatosa, to which he has belonged since 1987. He is presently the parish Verger as well as a Lay Reader and Chalice Bearer. He served on the Vestry from 2013 to 2017. He had also served on the Trinity Vestry many years before, service that culminated in three years as Senior Warden (1992-1994).
