Bishop Miller opened a short business meeting at 2:48 p.m.

#### • Discussion/Action Items

#### **Meachem Grants – Mr. Henry Peters**

Mr. Henry Peters, as representative of the Commission on Mission and Development, presented their recommendations for the 2013 Meachem Grants. The church, its location and program as well as the specific amount of the grant designated to it are located in the binder **Executive Council Resources** under Budget.

Mr. Henry Peters noted that the Committee on Mission and Development:

- --reviewed all proposals in terms of the merits of the ministry and if it lived into the congregation's mission and vision
- --looked at the congregation's grant and aid history
- --felt that some parishes' requests would fall under other grants

He also explained that:

- --on the chart, St. Alban's should be St. Aidan's
- --the zero amount to Good Shepherd will be altered to \$5,200.00 once the committee receives the requested additional information regarding the program

Bishop Miller noted that since the motion comes from a committee a second is not needed. He asked if there were any questions.

Mr. Rob Mortenson wondered if there was a procedure for notifying those parishes that were not fully funded and the rationale for the decision. Ms. Peggy Bean and Mr. Henry Peters noted that the committee would be meeting with all the parishes.

Bishop Miller then called for a vote. Several council members indicated the need to abstain. It was stipulated that, as in the past, the vote would be on the whole package with individual members abstaining on those line items relative to his/her parish. The vote to approve the Meachem grant proposals was unanimous with the respective abstentions.

Bishop Miller noted that these grants with the Executive Council approval now go the Trustees for their approval and the distribution of the funds.

## New Background Check Contract for Parishes - The Rev'd Carla McCook

The Rev'd Carla McCook explained that:

- --currently parishes are using Oxford Document for background checks at the cost of \$40.00 per individual
- --IntelliCorp can provide the same service for \$9.95 an individual and \$8.00 for Driver's Records per person

The Rev'd Carla McCook then asked that the Executive Council to approve the following agreement with IntelliCorp for parishes only.

IntelliCorp agrees to offer preferred pricing to any clients that The Episcopal Diocese of Milwaukee refers to us. IntelliCorp will offer customized solutions per referral client based on their specific needs as that is included in our full suite of products. IntelliCorp will work with The Episcopal Diocese of Milwaukee to develop specific solutions to each client in a collaborative effort to best meet the needs of the client/prospect.

The Episcopal Diocese of Milwaukee agrees to promote the relationship with their clients to the best of their ability.

This agreement can be revoked at any time by either party by a 30-day written notice.

Bishop Miller asked if there any questions or comments.

Mr. Gust Olson asked if a parish was obliged to use IntelliCorp.

It was noted that use of IntelliCorp was up to the parish.

Ms. Giannina "Nina" Radcliffe was pleased by this change as it made it easier for the parishes.

Bishop Miller noted that it needed to be amended in Best Practices to include the use IntelliCorp for non-ordained persons.

Ms. Giannina "Nina" Radcliffe moved to approve the agreement with IntelliCorp as stated above. Ms. Taryn Lantz seconded it. The motion carried unanimously.
